Fire Protection System Permit

General Information

- All work subject to field inspection and/or testing. NFPA 13D and 13R systems shall require a "bucket test".
- No work shall start prior to sprinkler permit issuance.
- The editions of NFPA 13, 13D, 13R, 14 and 303 referenced by the State Fire Prevention Code are adopted by the City of Annapolis.
- Plans and manufacturers' specs are required.
- The permit is valid for work commenced within a period of 120 days after issuance. Otherwise, it is void and of no effect. The permit shall be for periods as the fire chief determines, not to exceed 1 year.
- Issued sprinkler permits are not transferable for any reason.
- All fees are not refundable for any reason.
